 What is the date for the special general election for Maryland's 7th Congressional District?

Tuesday, April 28, 2020.

2. Do voters need to request a ballot?

No. The State Board of Elections mailed ballots to all eligible active voters in the 7th District on April 8, 2020.

3. What if a voter needs an accessible ballot at home?

Voters can request a large print or electronic ballot online at <u>elections.maryland.gov</u> or from the Maryland State or your County Board of Elections (listed below):

Requests

- 4. What is the deadline to request an absentee or electronic ballot?
 - **Tuesday, April 21, 2020**, if you want to receive your ballot by fax or mailed to a different address.
 - Friday, April 24, 2020, if you want to download your ballot from the State's website.
- 5. What is the deadline by which voters must mail in their ballots?

Voted ballots including requested large print or electronic ballots must be signed, sealed and postmarked on or before April 28, 2020. No postage is required, and voters can use self-addressed pre-stamped envelope provided.

6. What if a voter cannot vote by mail?

To ensure that all voters have an opportunity to vote, there will be three inperson voting locations on April 28, 2020 for voters to cast their ballots. These locations will be open from 7:00 AM to 8:00 PM. The locations of the vote centers are:

7. How do voters know if they are registered to vote in the 7th District?

If you aren't sure if you are registered, or at what address, check your voter registration status by visiting <u>www.elections.maryland.gov</u> and clicking "<u>Look up your Voter Info</u>." If you do not have internet access, call **1-800-222-8683** and ask a State Board of Elections representative to check your registration.

8. What kind of identification is required to cast a ballot by mail?

If you are a registered voter in the 7th District and voted before, no identification is required to receive or submit a ballot by mail. A very small number of newly registered voters may need to provide ID with their voted ballots. If you have to provide ID, there will be instructions with your ballot.
